1. Background of Business Alliance

FEWLAPS is a development company which develops the health app, "QuitNow! – Quit smoking", an app which is designed to help people to quit their smoking habits.

The app is a popular app which has marked over 2 million cumulative downloads*1. It comes with various unique features such as a feature for managing the time period which the users have refrained from smoking, the number of cigarettes they have not smoked, the amount of money that they have saved by not smoking, and even calculates the increased lifespan of users, all in real-time. It also comes with a milestone feature which congratulates users upon achieving certain milestones (such as "3 consecutive smoke-free days") which allows users to continue their smoke-free periods with a game-like feel and user talks with other user that are quitting smoking.

Users can also easily check how much their health has recovered, based on WHO (World Health Organization) standards.
